## What we are doing

From 6 to 8 November 2023, we will be breaking out concrete to remove a temporary foundation, north of the Chiltern rail line within our Copthall tunnel site boundary.

The removal of the concrete foundations will enable access for the main conveyor maintenance team. It will also clear the area in preparation for the eastern portal construction. The location of the work is shown on the map below.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.
