High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.


# Relocation of Bus Stop J - Hampstead Road

As part of our essential programme of utilities works, and to ensure that bus stops along this route will not need to be suspended, we are relocating Bus Stop J to a location further South on Hampstead Road. We will also be locally relocating Bus Stop K to ensure both stops are not opposite each other to aid with traffic flow.

These works will commence on **Monday 16 October 2023** and will last for seven days and will be completed by 22 October 2023. Working hours will be 10pm – 5am and the following traffic management will be in place during this time:

- Night-time lane closures on Hampstead Road
- Temporary cycle lane closures on Hampstead Road
- Temporary traffic lights at the Drummond Street junction
- Night-time closures of bus stops J and K

Please note that outside of working hours, all bus stops will remain open for the duration of these works and pedestrian access along Hampstead Road will be maintained.

## **Duration of works**

- 16<sup>th</sup> October 2023 to end of November 2023.
- Start-up and closedown activities up to one hour before and up to one hour after working hours

# What to expect

- Temporary worksites where work is taking place
- Traffic management in place
- Pedestrian access will be maintained

- Aim to reduce noise and vibration as reasonably practicable
- Keep all sites safe and secure

# **UKPN Works 23rd October 2023**

Following on from these works, UKPN will be carrying out essential utility diversions in the area until the end of November 2023.

There will be traffic management on Hampstead Road as well as a short-term closure of Robert Street and a short term no-entry into Varndell Street from Hampstead Road. Small sections of North Gower Street will also be impacted, however, pedestrian access will be maintained.
