High Speed Two (HS2) is the new high speed railway for Britain. Early works for Curzon Street station are being carried out by a joint venture between Mace and Dragados (MDJV).

Single lane restriction on Curzon Street

The pedestrian site entrance at gate 2 on Curzon Street requires the cobblestones to be temporarily removed and the area made safe with an interim reinstatement. This is due to the cobblestones coming loose and hazardous to walk over.

These works are planned over 3 days from Friday 27 to Sunday 29 October.

To carry out these works safely we will need to put in place a lane restriction on Curzon Street just outside the site entrance. The footpath on this section of Curzon Street is currently closed to pedestrians.

When will these works take place?

Friday 27 to Sunday 29 October 2023.

- Advanced roadside notice
- Single lane restriction on Curzon Street
