



# Notice of road closure Aston Church Road – Birmingham

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## Constructing a new Aston Church Road bridge

To create space for the new HS2 trains to run into and out of Birmingham we need to build a new bridge on Aston Church Road. We need to do this work because the existing bridge does not currently allow enough headroom for the HS2 line to pass underneath.

To rebuild the bridge, as well as to safely move several utility service apparatus and to finally connect the new road to the existing road we will need to close a section of Aston Church Road for a period of 14 months.

We plan to close the road from Monday 25 March 2024 and reopen it on Monday 26 May 2025. These are earliest dates subject to consents.

## Diversion route

To keep traffic moving in the area cars will be diverted along A47 Heartlands Parkway, Saltley Viaduct and Washwood Heath Road. Access to businesses and properties will be maintained.

Footway diversion routes will be shared with communities ahead of the closure. There are no impacts to bus routes.

## Travel times

We understand that travel times may be impacted due to the diversion routes and would advise road users to plan their journeys in advance. Where possible we would advise road users to consider the timings of their journeys to avoid peak traffic hours as well as considering whether they need to drive or if they could use an alternative method of travel.

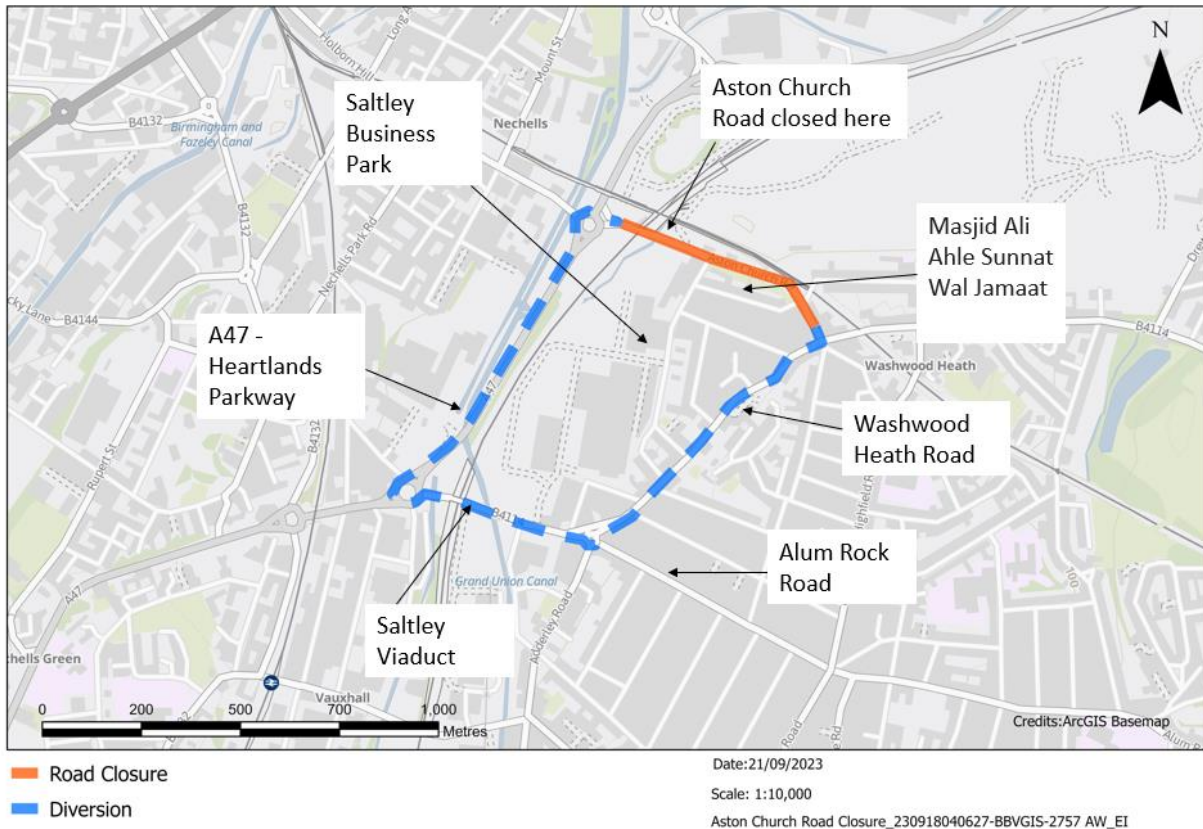
