High Speed Two (HS2) is the new high speed railway for Britain. This notification is to inform you of temporary traffic lights on our temporary access road on Bottom House Farm Lane, Chalfont St Giles.

How will this affect you?

To enable works on the carriageway on the temporary access road parallel to Bottom House Farm Lane, Chalfont St Giles, Buckinghamshire, temporary traffic lights will be installed from:

- 23 October to 1 December

The temporary traffic lights will remain in place and operational throughout these dates.

What will we be doing?

A mobile works unit and operatives may be visible on the temporary access road while we carry out drainage improvement works to the carriageway. Please see the location map of these works on page 2.

Access for residents and pedestrians

Residential access will be maintained via the temporary access road. Access for the emergency services will also be maintained at all times.

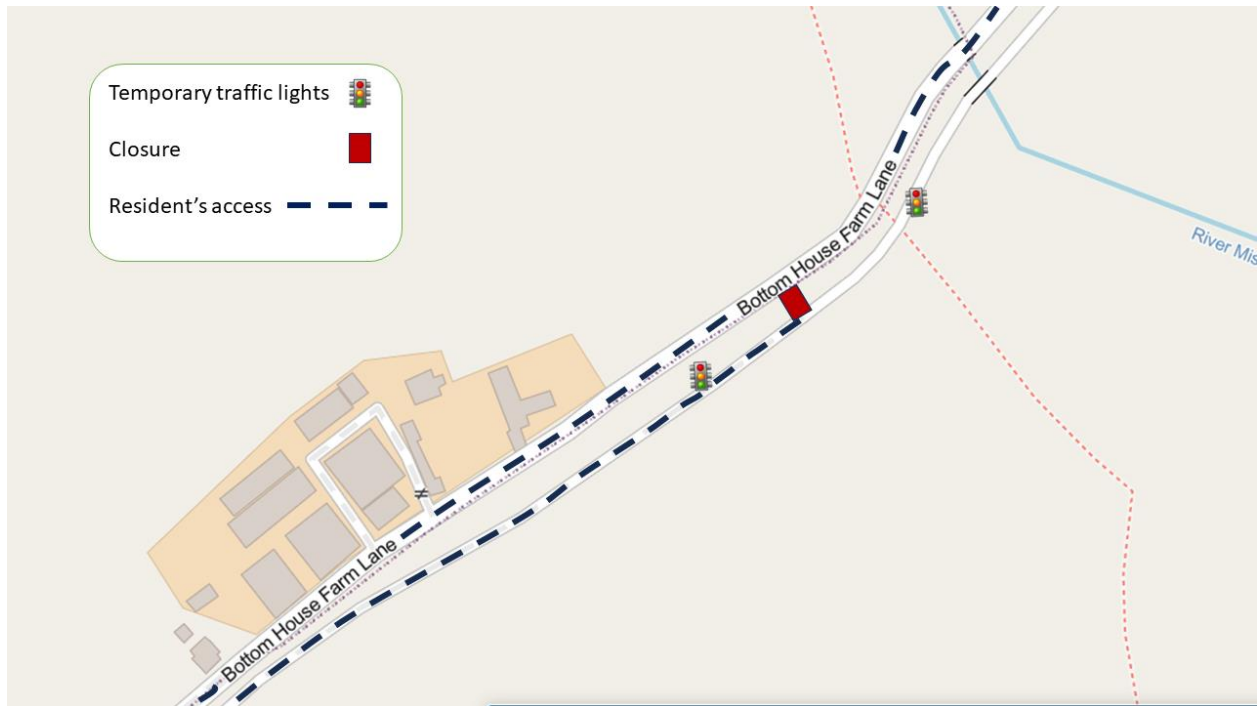

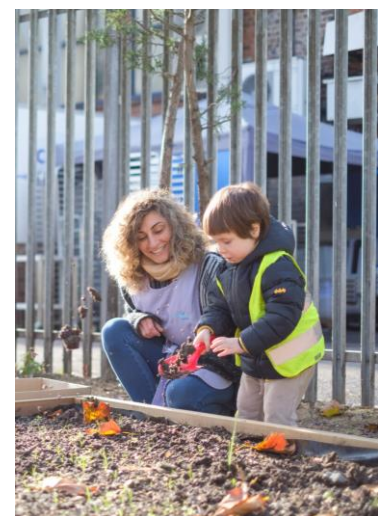
About our Community and Business Funds
