



# Notice of Bromford Drive footpath closure

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

## Diverting utilities by Bromford Drive

To construct the railway, we need to carry out utility diversions along Bromford Drive. To carry out these utility diversions safely, we need to manage pedestrians in the area.

We will therefore be closing approximately 25 metres of the footpath along Bromford Drive from Monday 23 October to Friday 1 December 2023. During this time a diversion route will be in place for pedestrians.

The Bromford Drive carriageway will remain open.

Our workforce may be on site up to one hour before and one hour after, to set up and take down equipment.

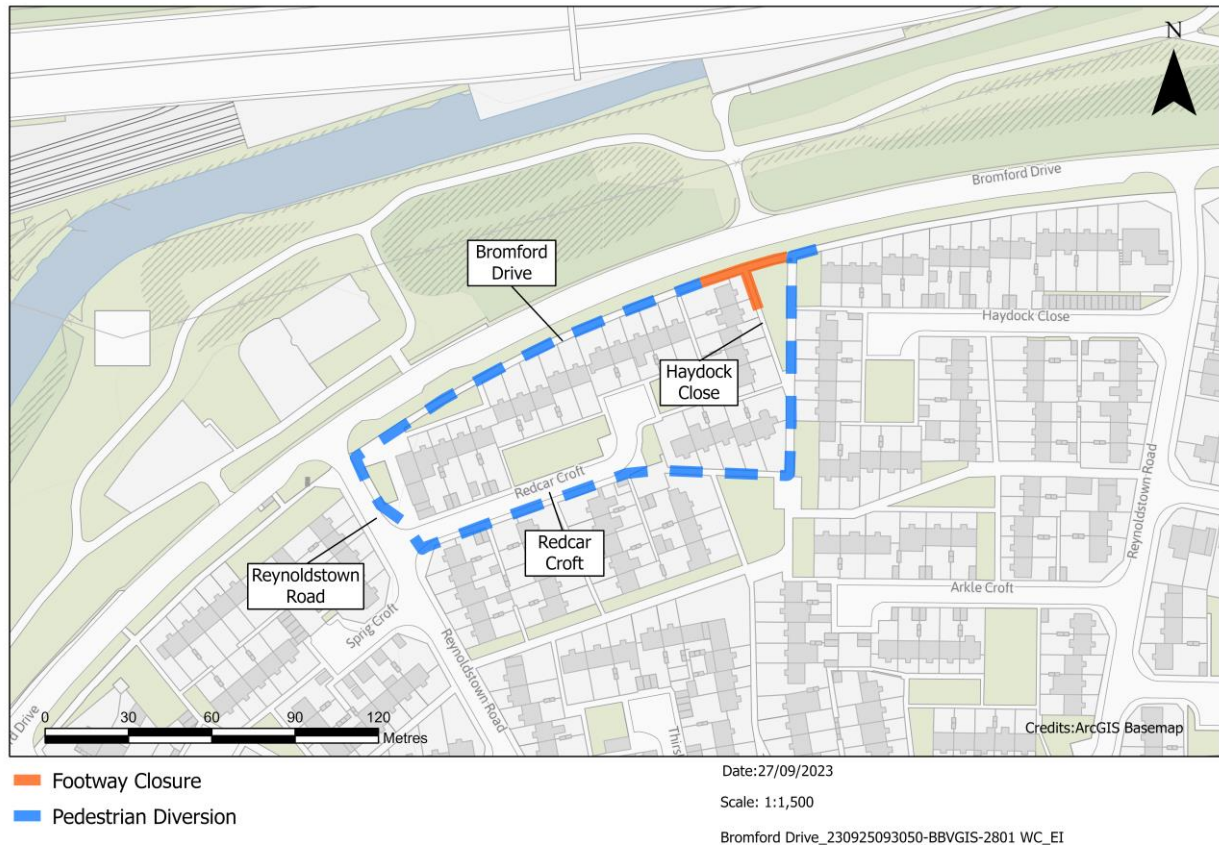

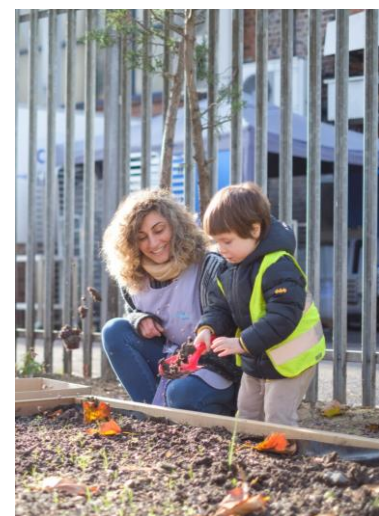
## About our Community and Business Funds
