Crane Removal from Mandeville Road Vent Shaft

On 18 October 2023, we will be removing one of the cranes from our Mandeville Road Vent Shaft site as it has a mechanical fault which cannot be corrected on site. As a result, we will also be delivering a new crane as a replacement.

Due to the abnormal loads movement order regulations from National Highways, we need to do this within particular hours. This will take place between 10pm on 18 October and 6am on 19 October as it needs to be off the M25 before 6am.

We would like to apologise in advance for the disruption or inconvenience this may cause. Every effort is being taken to ensure that these deliveries are carried out in the least impactful way.
