# **HS2 Update**

Euston Approaches | September 2023

High Speed Two (HS2) is the new high speed railway for Britain.

Skanska Costain STRABAG (SCSJV) is the main works contractor building the HS2 tunnels and infrastructure between Euston and West Ruislip. The section between London Zoo car park and Hampstead Road is known as the Euston Approaches.

#### **Ongoing works in the Euston Approaches**

In March 2023, the Government announced that HS2 will not proceed with the full construction of Euston Station in the next two years. A copy of the Transport Secretary's statement is available online.

As a result of this decision, major excavations to construct the Euston Approaches tunnels, concrete box and railway cutting have been paused until 2026. In the meantime, we will continue works to extend Granby Terrace and Hampstead Road bridges and prepare for tunnelling.

## **Building the Euston Approach tunnels**

This newsletter also provides an overview of the construction of the Euston Approach tunnels, including where they are, how we will build them and what to expect.

We will work 24 hours a day, 7 days a week to construct the Euston Approaches shaft and tunnels between Parkway and south of Mornington Street bridge.

We plan to start tunnelling activities in 2026 and most of the work will be underground. However, there will also be teams working above ground to prepare equipment and materials and remove the excavated material.

## **Road works on Hampstead Road**

To prevent disruption to local utility services, we are moving utilities away from Hampstead Road before we start works to extend the bridge. Once we have finished extending the bridge, we will put the utilities back onto Hampstead Road. This means you will see ongoing changes to the traffic arrangements on and around Hampstead Road for several years.

We continue to coordinate traffic arrangements with other contractors in the area and do our best to maintain direct vehicle and pedestrian routes through the area. We apologise for any disruption caused by these activities.

## **Tunnelling in the Euston Approaches – starting 2026**


In 2026 we will begin tunnelling in Euston Approaches. We will excavate three tunnels beneath the railway cutting and a small section of the Park Village East carriageway, between Parkway and south of Mornington Street bridge. First, we will dig a deep shaft beneath track-level just south of 1 Park Village East, then we will start digging the tunnels. Our team will work 24 hours a day, 7 days a week. It will take about five years to construct the tunnels in Euston Approaches.

We are not using a tunnel-boring machine in the Euston Approaches. Instead, we will use excavators, spraying the tunnels continuously with concrete as we excavate. This is a tried and

tested construction method known as sprayed concrete lining (SCL) tunnelling. The Euston Tunnels, which run from Old Oak Common and connect into the Euston Approaches tunnels will be constructed using tunnel boring machines.

While most of the 24/7 construction activity will be underground, there will be ongoing work above to provide equipment and materials to the worksite.

## **Removing excavated materials**

We will remove excavated material from the tunnels and excavation sites by lorries, which will eventually operate 24 hours a day, 7 days a week to keep up with the tunnelling and other works.

Within the worksite, we will use a conveyor to move excavated material beneath Mornington Street bridge to a stockpile ready for loading onto lorries. The conveyor will be fixed to the Park Village East retaining wall, below street level, and will operate 24 hours a day, 7 days a week.

We are working with Camden Council to agree measures to minimise dust, noise, light, and vibration during these necessary works. Though we work hard to reduce and monitor impacts, we recognise working 24 hours a day outside your home or business will be disruptive and we apologise. We are working to minimise the impact of these activities as much as possible.

#### Ground movement and repairs at the end of tunnelling

We expect a number of properties close to the tunnelling and major excavation sites will experience cosmetic damage from HS2 works. This damage can be unsightly but is not unsafe.

HS2 will repair, or pay to repair, any damage caused by HS2 works after tunnelling is complete. If damage is repaired while tunnelling is still under way, the damage may re-appear. Therefore, we plan to carry out repairs once the ground has settled after tunnelling and excavation is complete. We recognise there is a significant impact to people affected by damage and will always take the time to discuss and consider your situation.

We expect increased ground movement local to our works once we start digging at the northern end of site in 2026. We do not expect our works before then to cause any noticeable changes to ground movement.

### New site access and welfare building

In early 2026, we will install a three-storey office and welfare building for our tunnelling team in the Camden Cutting north worksite on top of a large steel frame (a gantry crane). You will be able to see the top of the frame as well as the building above the Park Village East hoarding and from the other side of the cutting. Unfortunately, there is no space to install this building at track level.

We will install a new pedestrian access to our worksite at the northern end of Park Village East. We will extend the hoarded lorry lay-by to just south of 1 Park Village East to enclose the new access and reduce noise and visual impact. Once we begin tunnelling this access will be used 24/7. ## **Working with communities**

#### **Vehicle Holding Area hoarding mural**

In March we unveiled a new mural on the side of our site hoarding at the Vehicle Holding Area. This mural was a collaborative project between SCS, North Bridge House Prep School and London Zoo. Over sixty pupils aged between 10 and 11-years-old were involved in painting images of animals and tribal patterns, inspired by the work of artist Louis Masai, whose art is displayed around London Zoo. The theme was endangered species with the pupil's taking inspiration from the inhabitants of the zoo. On 28 March the hoarding was unveiled, and pupils received certificates acknowledging their artistic achievements. This has been one of the biggest projects we have delivered in the area and was a great way for us to involve the school in something positive and long-lasting.





## Interactive road safety day

In July we hosted ninety 6 to 8-year-old students from Christchurch Primary school to learn about road safety and how to take care around larger vehicles. The Vehicle Holding Area was set up with four activity stations, including a concrete lorry, a tipper truck, a traffic light and crossing area, and a van and motorcycle from the local Transport and City Police.

The children were allowed to sit in the cabins of the large tipper truck and concrete lorry where they learnt about the limited visibility of the driver and the safety features of the vehicles. They practised crossing the road safely and learnt what the different road signs mean. The hit of the event was the police bike and police van where children learnt about speed limits and the role of the traffic police in protecting road users and pedestrians.
