High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

To continue our preparation for the construction of the HS2 railway, we will be carrying out works along Gilson Road. These works are to complete the construction of the plant crossing.

#### When the work will take place

To ensure the safety of our workforce and road users, we will be installing temporary traffic lights from Monday 30 October to Friday 17 November, 9:30am to 3:30pm each day.

Once the construction is complete, the plant crossing will be in operation. The plant crossing will operate from the Friday 17 October and will be controlled by traffic lights, giving priority to Gilson Road vehicles. The plant crossing will operate Monday to Fridays, 7am to 7pm and Saturdays, 8am to 4pm.
