High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

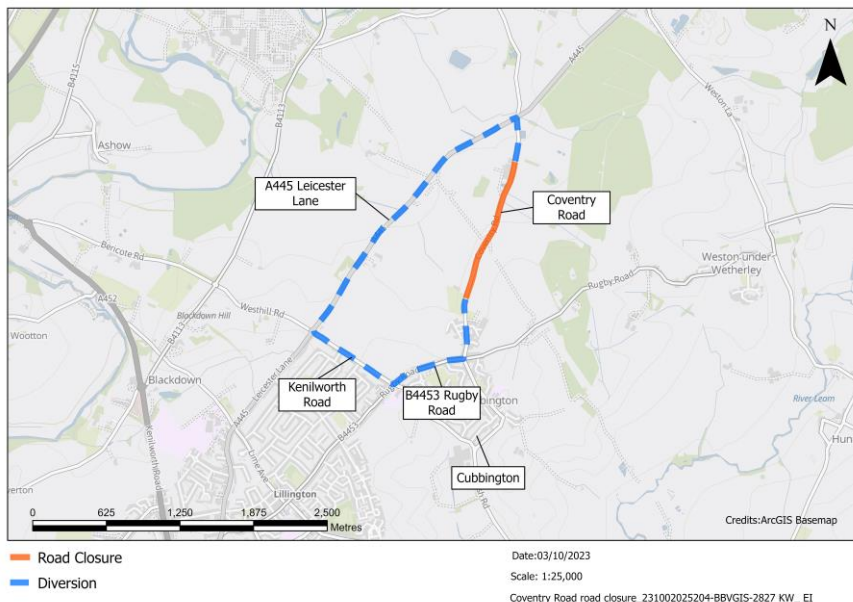
The work we will be doing

We will be carrying out utility diversion on Coventry Road. To carry these works out safely we will need to close a section of Coventry Road.

When will these works be taking place?

The road closure will be in place from 4 to 8 December 2023, from 9.30am to 3.30pm.

Access to properties will be maintained throughout. Our workforce may be on-site one hour before and after setting up and taking down our work equipment.

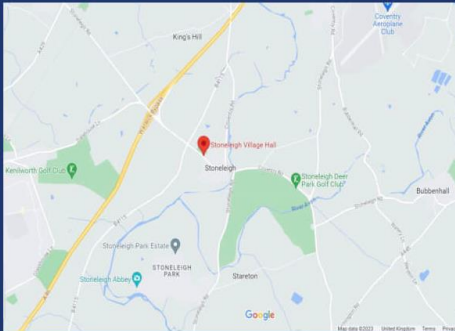

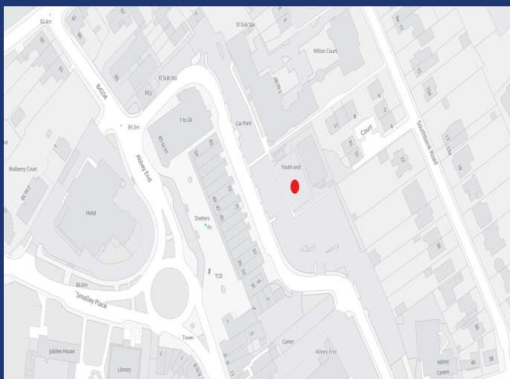
