



# Notice of temporary overnight closure – A452 Chester Road - Chelmsley Wood

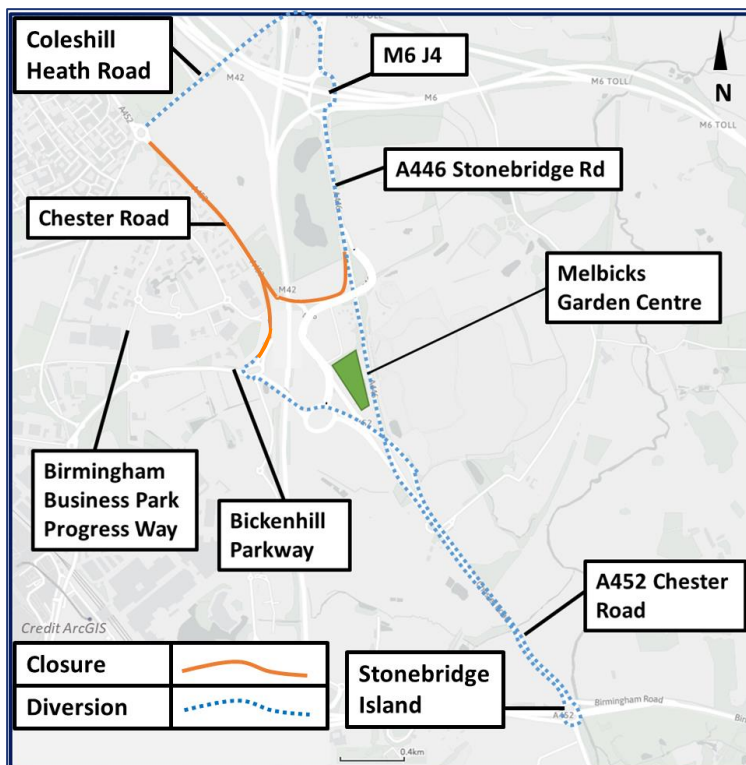

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

To ensure the local road network is fit for purpose when the future HS2 interchange station is operational, we have been improving and expanding the existing road network. A new roundabout has been constructed linking the A452 and the A446 to the Interchange Station site. As this work nears completion some remedial work needs to be done to the road surface, the kerbing, the verge drainage, and lighting. In order to do this properly and safely we will need to close the road for five consecutive nights from the new roundabout to Coleshill Heath Road. The work Will take place between 8pm at night until 6am in the morning from 13 November until 17 November.
