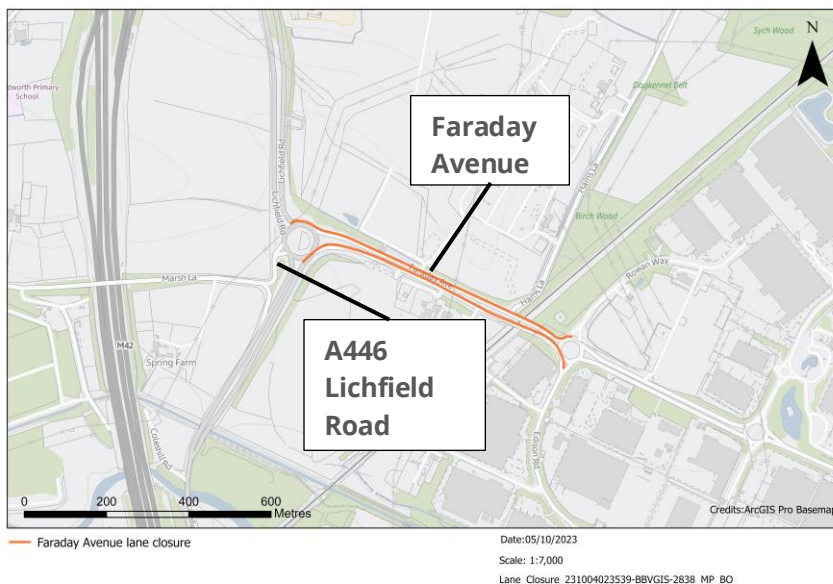
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing.

In the coming months we will be switching traffic, from the existing Faraday Avenue, onto a new temporary road diversion. This will allow works to commence on Faraday Avenue Underbridge. We will construct the new temporary road alongside the existing Faraday Avenue and will complete surfacing works and barrier installation. This will require traffic management to create a safe working area.

When the work will take place.

We will install single lane closures, on Faraday Avenue, on both the inbound and outbound carriageways. This will take place from 30 October to 30 November between 9.30am to 3.30pm (not including weekends). We will maintain three lanes running, out of four, at all times, during these works.



Duration of works

Single lane closures will be in place on Faraday Avenue from 30 October to 30 November between 9.30am to 3.30pm (not including weekends).

We will maintain three lanes running, out of four, at all times.
