High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing.

To carry out BT diversion and connection works for the new Stoneleigh Road overbridge. We will require overnight multi-way temporary traffic lights on Stoneleigh Road and close a section of Stareton Lane.

When will these works be taking place?

Stoneleigh Road will have temporary lights in place from 6 to 10 November 2023, overnight from 8pm to 6am, please refer to Map 1.

Stareton Lane will be closed overnight with a diversion in place from 6 to 10 November 2023, 8pm to 6am, please refer to Map 2.

Access to all properties will be maintained. Our workforce maybe on site one hour before and one hour after to set up and secure our equipment.

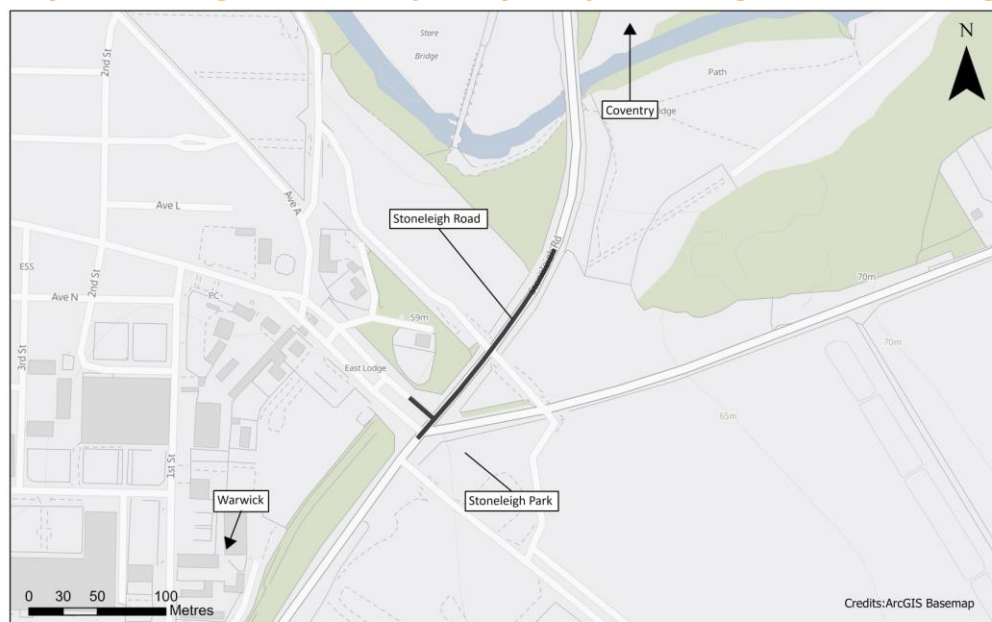

Map 1: Overnight multi-way temporary traffic lights on Stoneleigh Road



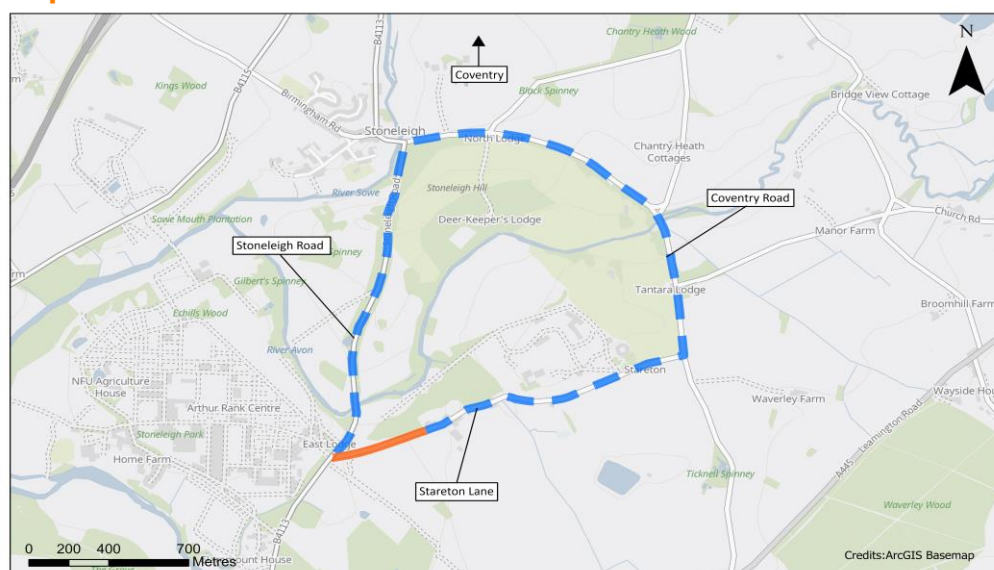

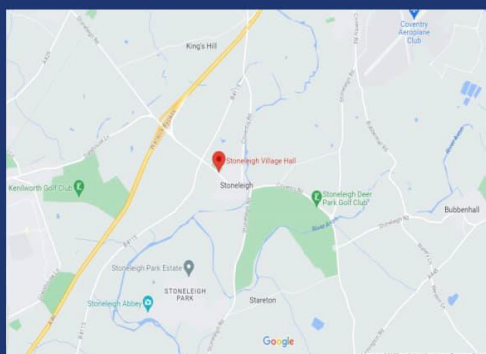
