High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will be carrying out utility trial hole surveys along the A425 Leamington Road. This work is required in preparation for the utility diversion works at A425 Leamington Road.

When these works will take place

Two way temporary traffic lights will be in place on Stoneleigh Road on A425 Leamington Road from 18 to 20 October 2023. The traffic lights will be in operation 24/7 lights with manual control during peak times.

Access to all properties will be maintained.

Our workforce maybe on site one hour before and one hour after to set up and secure our equipment.

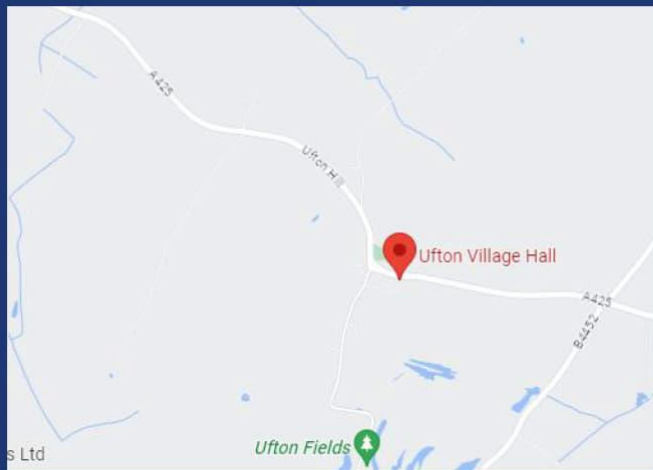
