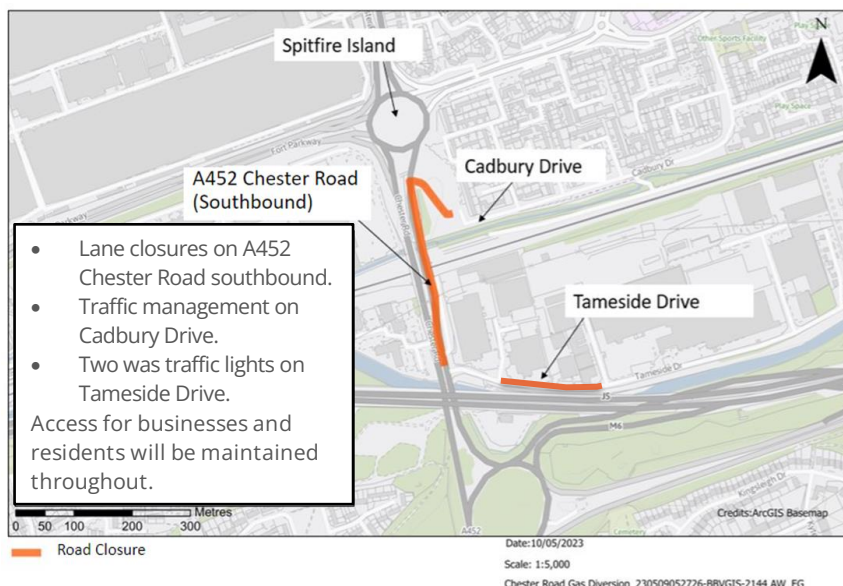
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci (BBV) is working on behalf of HS2 Ltd to build the new high speed railway in your area.

Update on the A452 Chester Road works

Owing to unforeseen challenges, our A452 Chester Road phased lane closures will need to be extended from 30 October 2023 to 3 November 2023.

We have been carrying out the work in phases

To minimise our impact on the road network, we have been carrying out our utility diversion in phases. Once we have completed the works on A452 Chester Road, we will commence work on Cadbury Drive. Two-way temporary traffic lights will be used during this period on Tameside Drive. We now expect the utility diversions to be completed and the traffic management on Tameside Drive and Cadbury Drive to be removed on 22 December 2023. Access for residents and businesses will be maintained at all times.

Works will continue until 22 December 2023

What to expect
Phased lane closures on the A452 Chester Road from 9:30am until 3:30pm.

Lane closures on Cadbury Drive between 8:30 and 4pm.

Two-way traffic lights on Tameside Drive between 8am and 6pm.

Access will be maintained at all times for residents and businesses.

What we will do
Clearly signpost these closures and explain these changes to road users and pedestrians.

Keep disruption to a minimum.

Answer your questions via the 24/7 HS2 helpdesk.
