



Update: Upcoming trial holes in the Camden area

High Speed Two (HS2) is the new high speed railway for Britain.

Trial holes in your area

We recently wrote to you in relation to us carrying out utility works on Eton Avenue and Loudoun Road. These works were due to start on 11 to 16 December 2023, but have been rescheduled and will begin on 29 January 2024 for Eton Avenue and 5 February 2024 for Loudoun Road.

Between **29 January to 3 February 2024** and between **5 to 10 February 2024** we will be carrying out a series of trial hole investigations on Eton Avenue and Loudoun Road.

The trial hole investigations will consist of digging a temporary trench to confirm the location of utilities under the surface of the road. The investigations will help us to understand the location of the utilities and the best ways to protect or divert any utilities during construction of the HS2 London Tunnels.

Your utility services will not be affected during these works.

We will use noise reducing barriers where possible to help minimise any noise disruption to the local community and work as efficiently as possible whilst keeping our work areas safe and tidy.

How will this affect you?

To ensure the safety of the public and our staff, temporary changes will be in place on Loudoun Road and Eton Avenue and will include lane closures, footpath closures and parking suspensions.

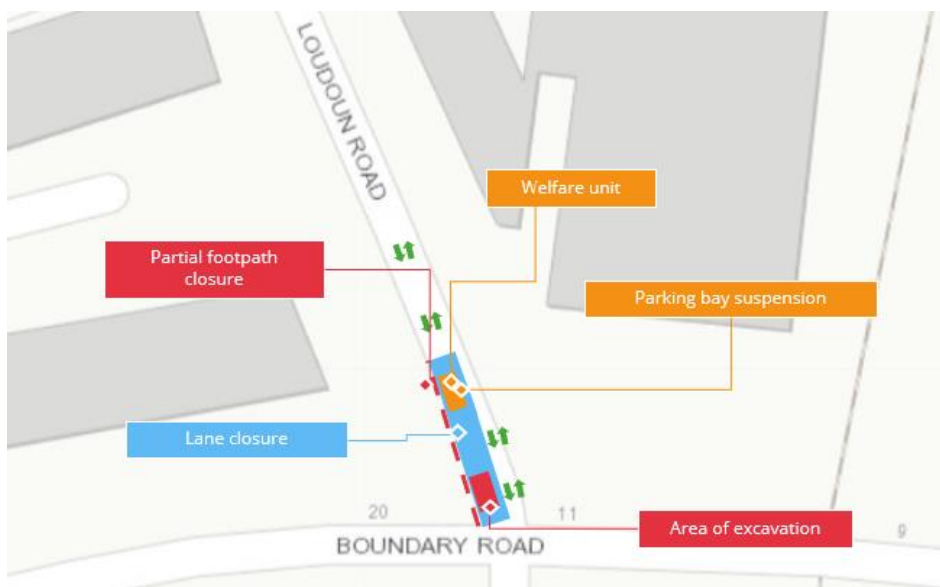
Eton Avenue: 29 January to 03 February 2024 (one week)
