High Speed Two (HS2) is the new high speed railway for Britain. This notification is to inform you that the machine building the Colne Valley Viaduct deck will cross Moorhall Road in Hillingdon.

Movement of launching girder over Moorhall Road

The launching girder being used to construct the Colne Valley Viaduct, named "Dominique", will soon mark the halfway point in the construction of Britain's longest viaduct by crossing over Moorhall Road in Hillingdon. Work to move the launching girder is expected to begin on Monday 6 November. Road traffic and pedestrians will not be affected by the works.

Work to transfer the launching girder over the pre-constructed deck over Moorhall Road will be undertaken from 6 November to 10 November. After this, the launching girder will resume operations in its new position south of Moorhall Road. The launching girder will then begin the final stretch of its journey building the deck across Savay Lake, the Grand Union Canal, and Harefield Lake no.2.

Duration of works

6 November to 10 November 2023, 24 hours a day, subject to weather conditions.

What to expect

Moving machinery on viaduct section over Moorhall Road, in Hillingdon.

Occasional noise from vehicles and machinery during movement of the launching girder.

Occasional noise from electric and hand tools, winches, and crane movements.

What we will do

Monitor noise during the movement of the girder.

Maintain access and movement along the public highway and footpaths.
