High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing.

Our team has encountered difficulty in installing the new electric cables near Coleshill Heath Road which has been damaged by flooding as a result of the recent severe weather.

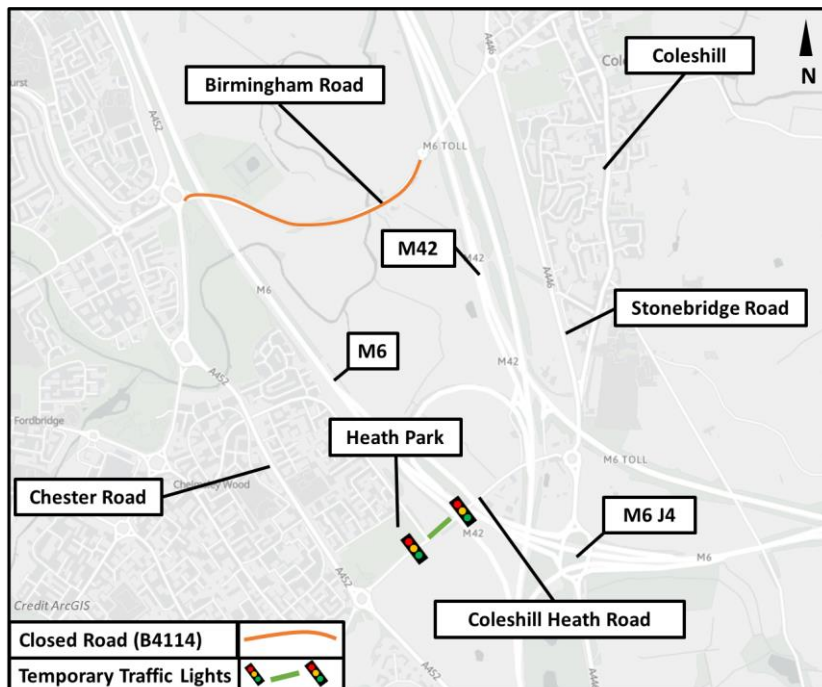
The team has unfortunately had to plan to replace this cable to prevent future issues and to meet the required standards.

There is no impact on the existing electricity network.

Tomorrow (10 November) between 11:00am and 1:00pm the team will be replacing this cable.

In order to do this safely we will need to control the traffic with temporary two-way traffic lights on Coleshill Heath Road between Yorkminster Drive and the bridge over the motorway.
