# Notice of lane closure on A45 Coventry Road - Bickenhill



High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

# The work we will be doing.

The new railway will pass under the A45 as it approaches the new interchange station. This requires significant work to the road network in this area. For the safety of all road users, we are required to carry out regular safety checks on and under the carriageway. In order to so this we will need to close a lane on the A45 between junction 6 of the M42 and Stonebridge Island. The work will take place overnight from 9pm on 18 December 2023 and reopen at 5:30am on 19 December 2023. These works are subject to consent.
