High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be doing

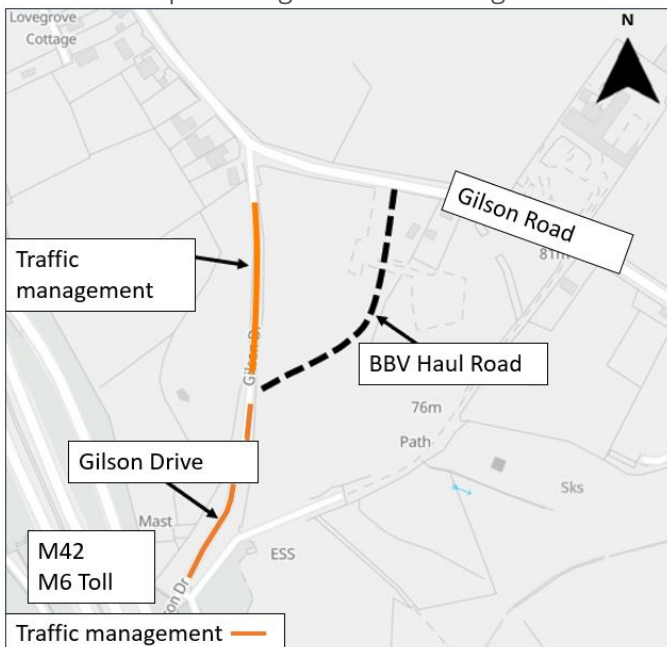
To enable the construction of the new railway we will be working on Gilson Drive. We will be undertaking earthworks and investigating known utilities in this area, to understand if there are any that we are not aware of. This is to ensure the safety of the road users and our workforce.

## When we will do the work

DATE UPDATE- Due to circumstances beyond our control these works will now take place from 4 December to 15 December. The closure will be in place from 8am to 6pm each day. **Access to properties will be maintained via the BBV Haul road.**
