



UPDATED: Notice of works on M42, M6 Toll Road, Water Orton

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To continue our works in the area, we will be undertaking works on the M42, M6 toll road, on the eastbound & westbound carriageways, to change the street lighting.

A breakdown of the work

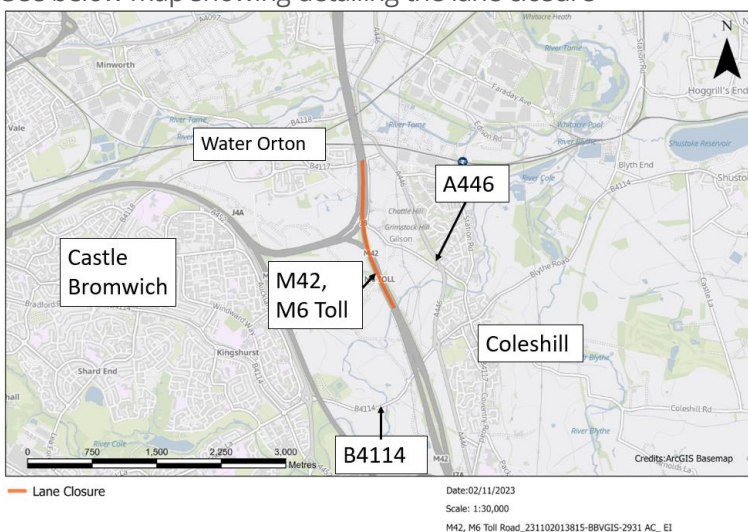
To minimise disruption and to ensure the safety of the road users and our workforce, the traffic management will be installed from 9pm to 5am each weekday and removed after every shift.

Overnight lane closures from 9pm on Wednesday 3 January to 5am on Saturday 20 January.

Updated: Due to recent weather conditions and a power cut, our works were delayed. In order to complete these works, we will be working an additional two nights, on Monday 22 January and Tuesday 23 January
