# Notice of works on M42, M6 **Toll Road, Water Orton**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

To continue our works in the area, we will be undertaking works on the M42, M6 toll road, on the eastbound & westbound carriageways, to change the street lighting.

#### A breakdown of the work

To minimise disruption and to ensure the safety of the road users and our workforce, the traffic management will be installed from 9pm to 5am each weekday and removed after every shift. This work is subject to daily consent so may not take place each day. This will be undertaken in two phases - see below breakdown:

- Three weeks of overnight lane closures from Monday 27 November to Saturday 16 December.
- One week of overnight lane closures from Wednesday 3 January to Wednesday 10 January.
