# Overnight sewer lining installation on Park Royal Road West

High Speed Two (HS2) is the new high speed railway for Britain.

# **Park Royal Sewer Lining Works**

From **27 November to 3 December 2023** we will be installing a new sewer lining to strengthen and protect the existing sewage structure once tunnelling begins.

These works will take place **from 8pm to 8am Monday to Sunday**. You may notice increased noise from our compressor machine for short periods of time and movement of trucks.

We will use noise reducing barriers where possible to help minimise any noise disruption to the local community, working as efficiently as possible whilst keeping our work areas safe and tidy.

# Where will the sewer lining installation take place?

We will carry out these works within the Lower Park allotments behind Western Avenue. Please see the map below showing the location of our temporary set up whilst installing the sewer lining.
