

Notice of building surveys in your area

High Speed Two (HS2) is the new high speed railway for Britain.

As part of our preparation work to build the new railway, we will be carrying out external surveys on buildings that are close to the proposed HS2 route.

When we will complete building surveys

We plan to carry out internal communal area and external building surveys in your area from Monday 20 to Saturday 25 November, between 8am and 4pm. We will be using a contractor to carry out these works. The surveying staff will be wearing high visibility clothing and displaying identification at all times.

How we will carry out the surveys

We will look at the external features and internal communal areas of specific buildings in your area. This will include taking photos and visually recording key features.

The type of information we need to collect includes construction materials, presence of basements, evidence of redevelopment (for example façade retention), particularly sensitive façades or finishes and an overall assessment of the building's condition.

We won't need access to any properties for the surveys. Residents' privacy will be respected at all times.

The dates may move due to unexpected changes to our survey programme and coordination with other construction works happening in your area.
