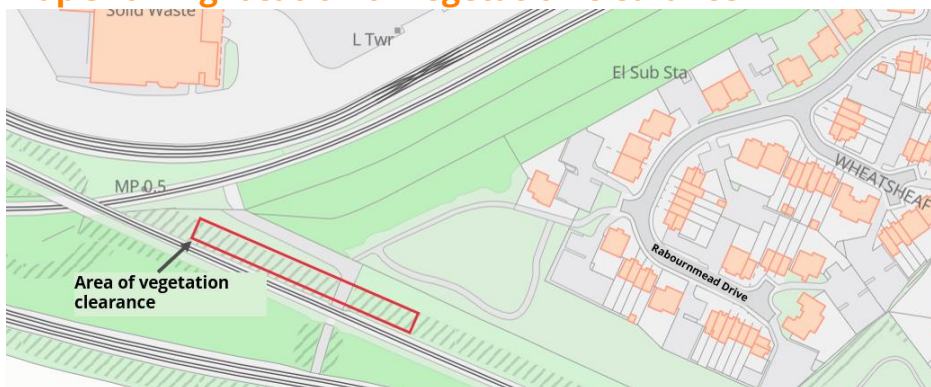
What we are doing

We will be clearing vegetation on the railway embankment around some monitoring equipment used to check for ground movement under the tracks. This work will take place on **Sunday 26 November between 8am and 5pm** at the rear of Rabournmead Drive Park.

As a contingency we may work on Sunday 3 December due to access issues on the railway.

Site teams will access the area from the park at the end of Rabournmead Drive.
