



Notice of road closure and traffic management on A446 slip roads – Marston Green

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

BBV have been significantly reconfiguring the junction of the A446 Stonebridge Road and A452 Chester Road near Birmingham Business Park to facilitate the construction of a bridge that will take the new railway over the M42. As this work comes near to completion we will be 'tying in' the new junction in to the existing. In order to do this we will need to undertake two phases of works:

Phase One

Weekend closure of the southbound slip road that connects the new junction to the A446 (this slip road is also known as Biddle's Loop), the junction will be closed from 8pm on 26 January and re-open at 6am on 29 January. To maintain access to Melbicks Garden Centre traffic will be able to make a right turn from the northbound carriageway of the A446 please see map below.

Phase Two

Following the full weekend road closure, we will re-open the newly constructed northbound Carriageway to traffic and the A452 southbound will remain closed towards Melbicks garden centre. The road will remain closed until 6pm on 6 March 2024 while we reconstruct the carriageway. Access to Melbicks garden centre will remain the same as phase one. Quartz Point business park access will be maintained through the lane closure on the southbound slip road from the A446.

This work is subject to consent.

Phase One - Closed from 8pm on 26 January 2024 and re-open at 6am on 29 January 2024.

Phase Two - Lane closure 6am on 29 January 2024 until 6am on 6 March 2024, access to Quartz Point business park only

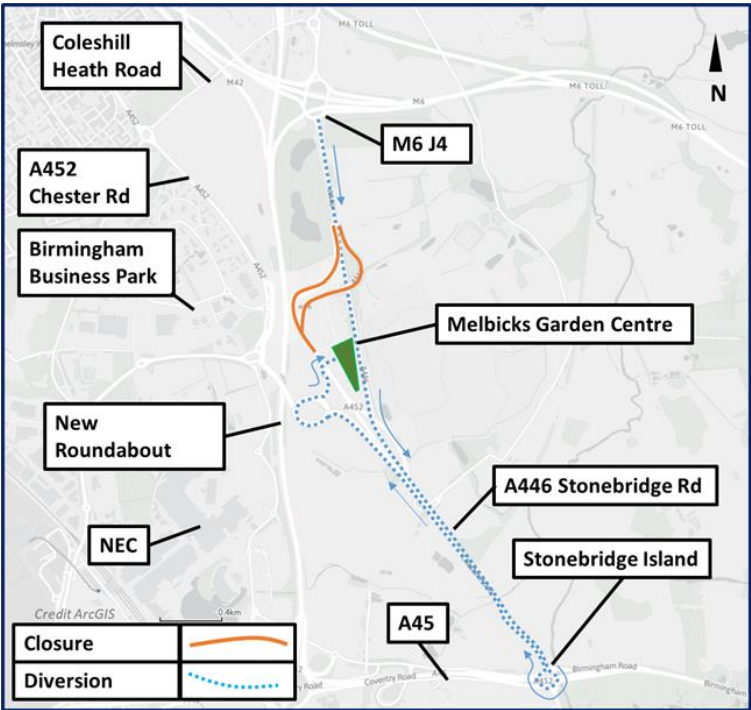

Phase One



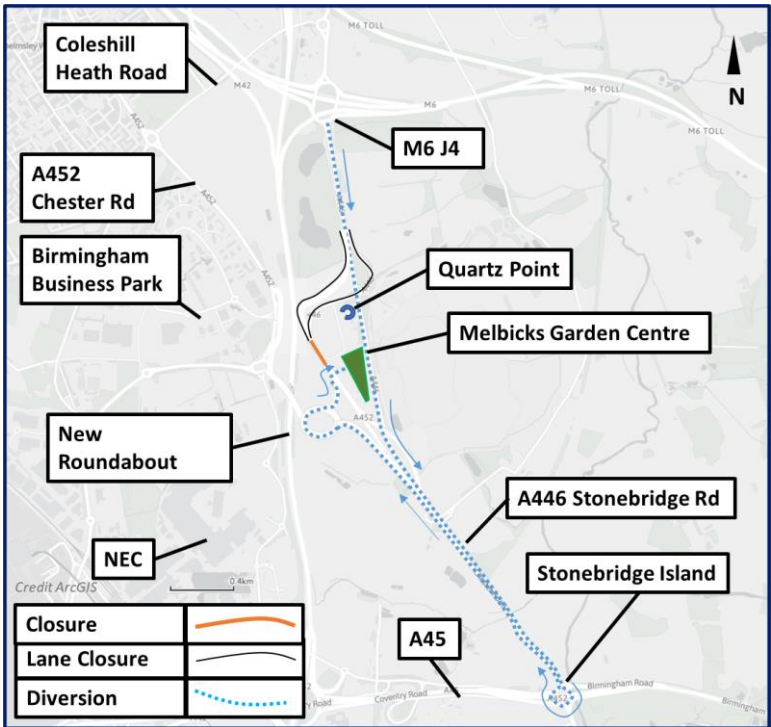
Notification
