What we are doing – Permanent Wall Construction

We wrote to you on 4 December 2023 to let you know that we would begin working on a permanent boundary wall on 8 January 2024. We've brought these works forward and will now start 2 January 2024. See map below showing the precise location of works indicated by the red arrow and letter B.

We will be excavating the ground, installing a concrete slab, which will support the wall, and then the build of the new permanent wall. We expect that this will create some noise and vibration. Noise and vibration monitoring will be in place at all times. We will also use acoustic barriers around the machinery to reduce the noise as much as possible.

We would like to apologise for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum and that regular updates are provided.
