What we are doing

The Mandeville Road Ventilation Shaft site will close for the Christmas period on 24 December 2023 and will reopen on 27 December 2023. There will be the usual security presence and only maintenance checks will be undertaken during the closure.

From **27 December 2023 onwards**, we will go back to our normal day and night shift working pattern. Work on site during the period between 27 December 2023 and 1 January 2024 inclusive will consist of sprayed concrete lining to the satellite shaft, and reinforced concrete works to the main shaft.

We will install acoustic barriers to reduce the noise impact of these works as we normally would and will be actively monitoring noise levels to identify and resolve any issues.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.

What to expect

You may notice large construction machinery and cranes on site during these works. The cranes will be lowered over the Christmas closure. As well as the operation of temporary ventilation plant and HGVs making deliveries and removing excavated materials. Cranes will be lowered over the Christmas Period 24 to 26 December.

What we will do

Use acoustic barriers around the machinery to help reduce the noise. Restrict certain activities to day time hours


