What we are doing

South Ruislip Ventilation Shaft site will close for the festive period from 22 December 2023 to 1 January 2024. There will be the usual security presence and only maintenance checks will be undertaken during this time.

From 2 January 2024 onwards, we will go back to our normal working day shifts. From 15 January 2024 to 31 August 2024, we will work some evenings and weekends.

Works starting in the New Year will consist of reinforced concrete works, headhouse construction, boundary walls, underground services, fencing and landscaping works.

We will install acoustic barriers to reduce the noise impact of these works.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.

The site will be closed from Friday 22 December until Monday 1 January 2024

From 2 January 2024 onwards we will go back to normal day shifts.

From 15 January 2024 to 31 August 2024 will include some evening and weekend working.
