## **Notice of closure of B4114 Birmingham Road, Coleshill**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

#### The work we will be completing

We are continuing to prepare for works to construct the Coleshill Viaducts that will carry the HS2 railway over the existing B4114 Birmingham Road. As part of this, we will complete works to tie in a new temporary road realignment for the B4114 Birmingham Road. This realignment will remain in place for the duration of the viaduct works.

#### **Traffic management**

To complete the works safely, we will install a four-week closure. The closure will be in place from Monday 8 January until Sunday 4 February, 24 hours a day, seven days a week.

Access to pedestrians, cyclists, businesses and residents will be maintained throughout the works and a clear diversion route will be in place at all times.

#### **B4114 Birmingham Road closure diversion**

The diversion route from the Chelmsley Wood end of the B4114 will follow the A452 southbound, along Coleshill Heath Road and via the A446 Lichfield Road northbound.

The diversion route from the Coleshill end of the B4114 will follow the A446 southbound, along Coleshill Heath Road and via the A452 northbound.

The diversion route is shown in blue, and the closure location is shown in orange on the map overleaf.


