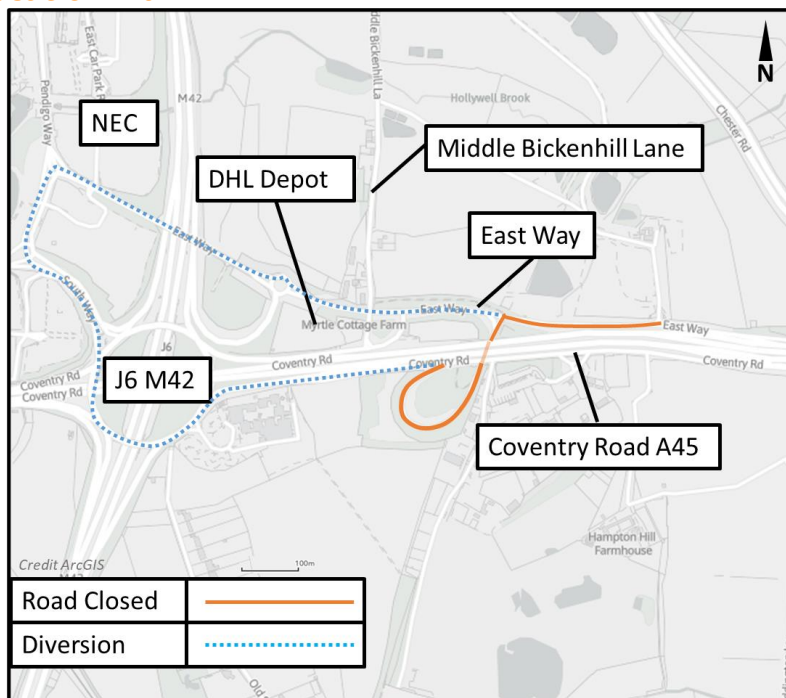
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

The work we will be doing

The new railway will pass under the A45 as it approaches the new interchange station. This requires significant work to this section of the A45 and the adjoining slip road known as 'East Way'. Before these works can take place, a number of utilities need to be moved and diverted to make sure that our works do not have an impact on the supply. To do this safely we will need to close the road overnight, every night for six weeks beginning on 8 January until 16 February 2024. The works will take place overnight each night between 8pm and 6am. A signed diversion will be in place, details of the route are on the map below. There will also be a lane closure on the A45 eastbound for safety purposes.

These works are subject to consent.
