High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

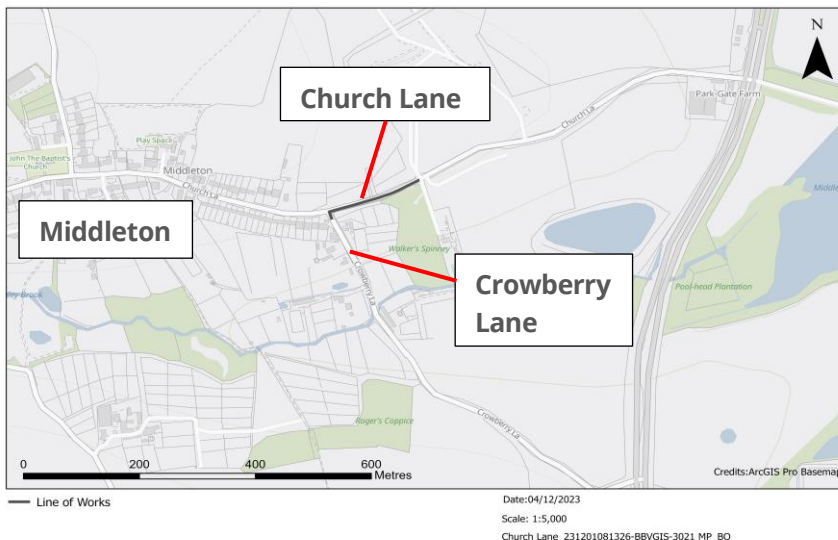
The work we will do.

We will be undertaking works to prepare for a utility diversion along Church Lane, Middleton.

These works will require us to locate and survey utilities that are underneath the ground then assess the condition ahead of further works. To ensure we can complete these works safely we will install temporary traffic management to create a safe working area and ensure the safety of road users.

When the work will take place

To complete these works safely we will install temporary three-way traffic lights between Church Lane and Crowberry Lane from Monday 29 January to Friday 9 February between 9am to 4pm (Mon-Fri).
