High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

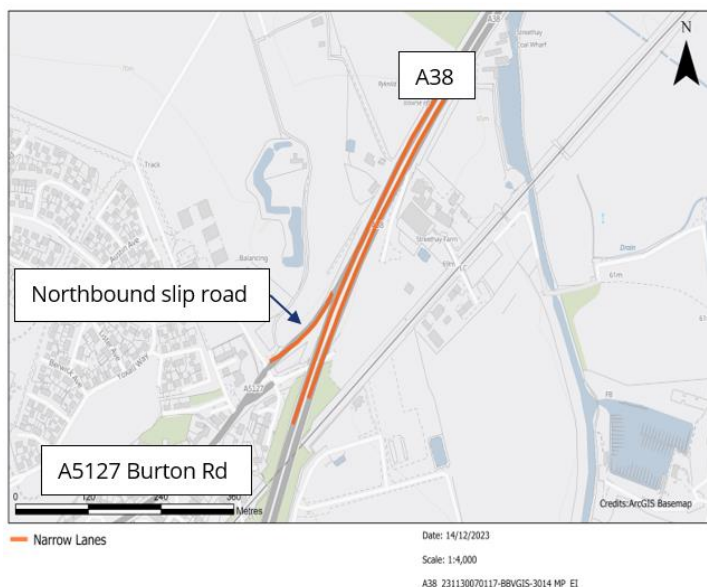
The work we are completing

To enable the HS2 line to pass under the A38, a retained cutting is being constructed, that will support three bridges including:

- Streethay Overbridge (South Staffordshire Railway) which was completed earlier this year.
- A38 Southbound slip-road Overbridge which is currently being constructed during the closure of the southbound slip-road.
- A38 Rykneld Street Overbridge which will commence in 2024.

A38 narrow lanes

As we progress our works on the A38 at Streethay we will continue to manage the flow of traffic using narrow lanes. We installed the narrow lanes in October 2022 and these will remain in place until Summer 2025.
