



## Notice of temporary footpath closure – Saltley Viaduct

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

### Footpath Closure

We will be installing sections of concrete in the footpath along parts of Saltley Viaduct as we commence preparation works for the new Viaduct that HS2 trains will travel under in the future.

In order to keep the public and our site teams in a safe environment, we will require a temporary footpath closure whilst we complete these works. From Monday 8 January 2024, for approximately six months, one side of the footpath will remain closed in order to carry out the concrete works. A temporary diversion will be in place which is displayed in the map below.

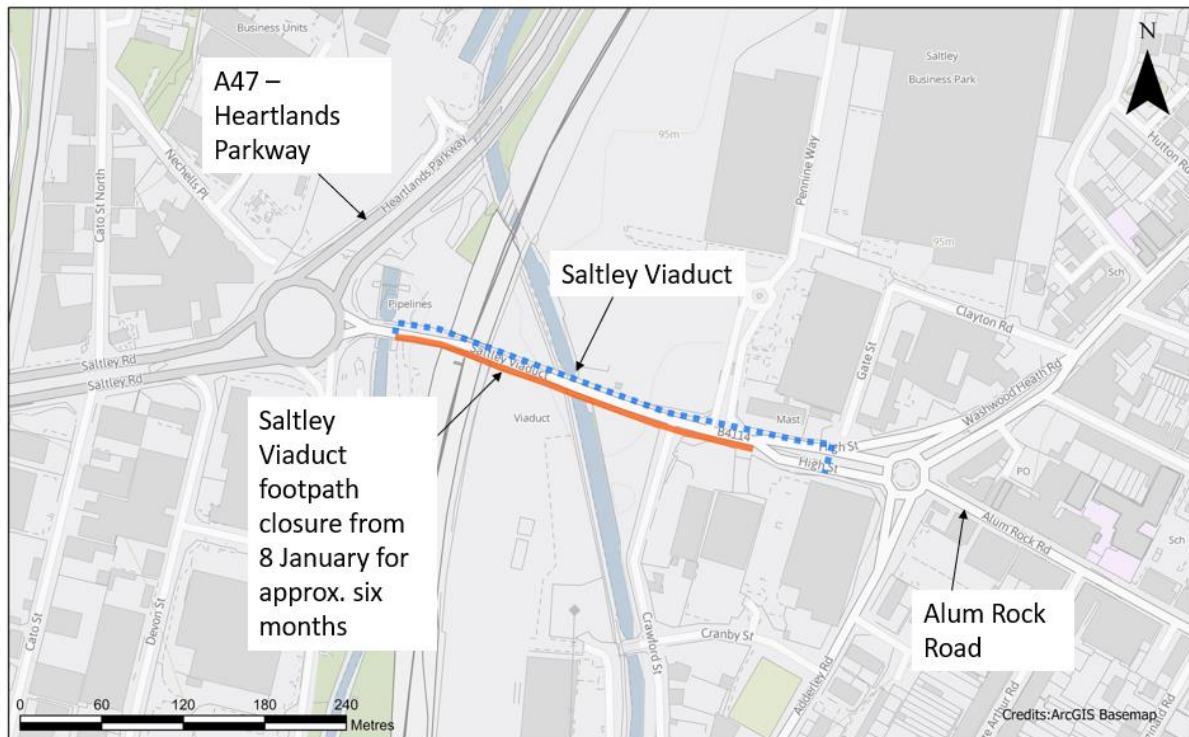
