High Speed Two (HS2) is the new high speed railway for Britain.

Thames Water update

Thames Water will install a protective tunnel lining to an existing raw water tunnel, to provide added structural stability during future underground HS2 works.

The main work will be undertaken within Barrow Hill reservoir site, with the site on Grafton Crescent being required for emergency access only.

Our work

The work is expected to last from Thursday 4 January to Tuesday 16 April 2024.

We will monitor noise levels, but do not expect to create high levels of noise as most activity will be carried out underground.

Find out more

There will be a one lane closure and a one-way system operating in Grafton Crescent while we carry out the works.

Access will be from Castle Road with exits onto Castlehaven Road. Public footways will remain open. There will be two parking bay suspensions, one bay to the side of 117 Castlehaven Road and one bay to the side of 119 Castlehaven Road.

About our Community and Business Funds

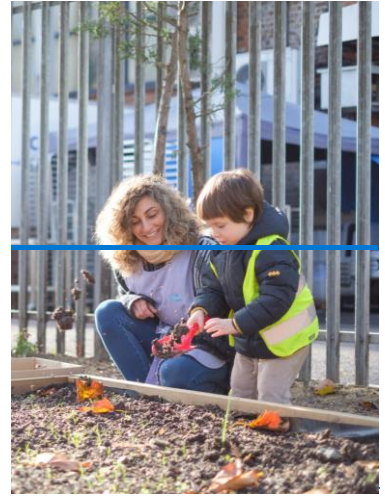
