High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

Our works

We will be undertaking emergency overnight resurfacing works on A4097 Kingsbury Road. The works are to repair some cracks that have emerged in the road surface, following the construction of the new roundabout.

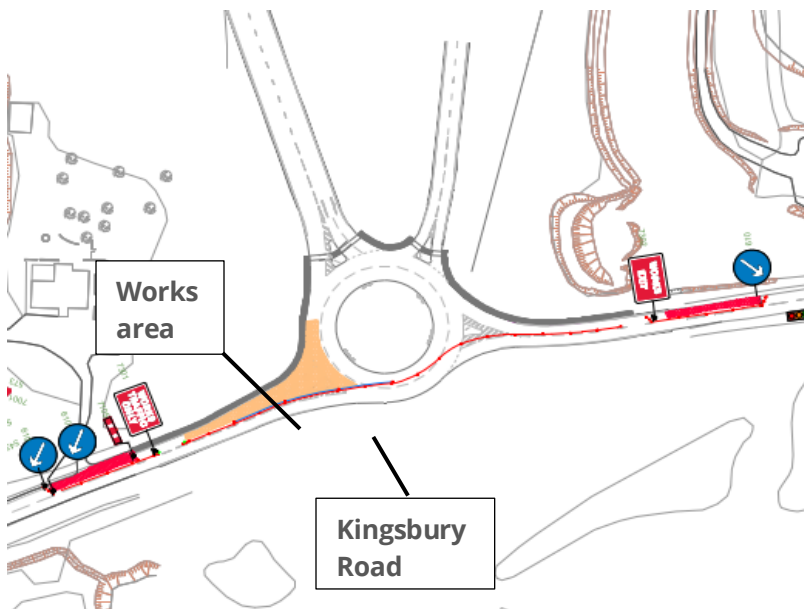
To undertake these works efficiently and safely, temporary traffic lights will be installed to facilitate the repair process.

These works will take place as follows:

Start: 8:00 PM on Wednesday, 20, 8:00pm Thursday, 21, December 2023,

End: 5:00 AM on Thursday, 21, 5:00am on Friday 22 December 2023
