High Speed Two (HS2) is the new high speed railway for Britain.

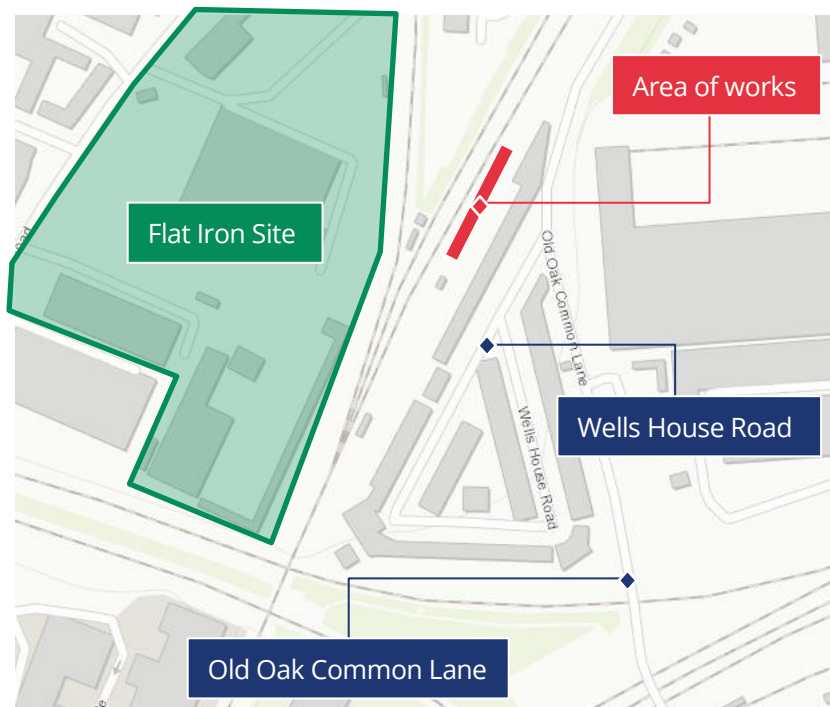
Vegetation Clearance on Network Rail embankment

From 9.30am on 14 January until 1.30am on 15 January 2024 we will be undertaking vegetation clearance on the Network Rail embankment behind Wells House Road.

These works will take approximately 16 hours to complete.

We'll use hand tools to remove the overgrown vegetation, and noise reducing barriers where possible to help keep noise to a minimum. We'll work as efficiently as possible, while keeping our work areas safe and tidy.

The vegetation clearance is to ensure a direct line of sight between equipment used to take optical measurements on and around our sites and Network Rail tracks and structures.
