High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing.


A routine inspection has uncovered a defect in a chamber on the link road over the M42 from the new roundabout to the smaller roundabout outside Birmingham Business Park and the NEC. This work is safety critical and as such we are proposing to close the southbound carriageway at 10:30pm on 24 January re-opening at 6am on 25 January to repair the defect.

There will then be a lane closure in place on the southbound carriageway from 6am on 25 January until 10:30 pm on 26 January to allow the repairs to cure.

A second full closure will be required on from 10:30pm on 26 January until 6am on 27 January to re-instate the tarmac around the chamber.

A fully signed diversion via Coleshill Heath Road will be in place.
