High Speed Two (HS2) is the new high speed railway for Britain. As part of our preparation work to build the new railway, we will be carrying out external surveys on buildings that are close to the proposed HS2 route.

WHEN WE WILL COMPLETE THE BUILDING SURVEYS

From **29 January till 9 February 2024**, we will be carrying out external building surveys on industrial units in your area. These works will be taking place **Monday to Friday from 8am and 4pm.** We will be using a contractor to carry out these works. Surveying staff will be wearing high visibility clothing and are mandated to display identification at all times.

HOW WE WILL CARRY OUT THE SURVEYS

We will look at the external features of specific buildings in your area. This will include taking photos and visually recording key features.

The type of information we need to collect includes construction materials, presence of basements, evidence of redevelopment (for example façade retention), particularly sensitive façades or finishes and an overall assessment of the building's condition.

We won't need access to any properties for the surveys. Your privacy will be respected at all times.

The date may move due to unexpected changes to our survey programme and coordination with other construction works happening in your area. We will keep you informed of all relevant changes.
