# **Notice of traffic management** on Coventry Road, Cubbington

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

# The work we will be doing

We will be completing temporary utility diversions and connection works along Coventry Road. This is to facilitate the construction of the new overbridge.

To ensure the safety of our public and workforce, we will be installing traffic management on Coventry Road between A445 Leicester Lane and Rugby Road.

# When these works will take place

We will be closing Coventry Road between A445 Leicester Lane and Rugby Road from 5 to 9 February 2024, from 9.30am to 3.30pm

Outside of these hours, there will be temporary traffic lights in operation to protect our working area. During peak times, these will be manually controlled to help the flow of traffic. Access to all properties will be maintained.

Our workforce may be on site up to one hour before and one hour after to set up and secure our equipment.



Coventry Road, Cubbington Diversion Route\_240102034909-BBVGIS-3080


