
The work we will be doing

To prepare for the construction of Dalehouse Lane Overbridge we will firstly complete a temporary diversion and connection of utilities along Dalehouse Lane. To ensure the safety of our workforce and the public we will install a road closure, that will be in place for 24 hours each day, for the duration of the works.

When we will complete these works

We will be closing Dalehouse Lane between Common Lane and Stoneleigh Road from 12 February to 1 March 2024

A full road closure will be in place during these dates. Please use the signed diversion route during the closure.
