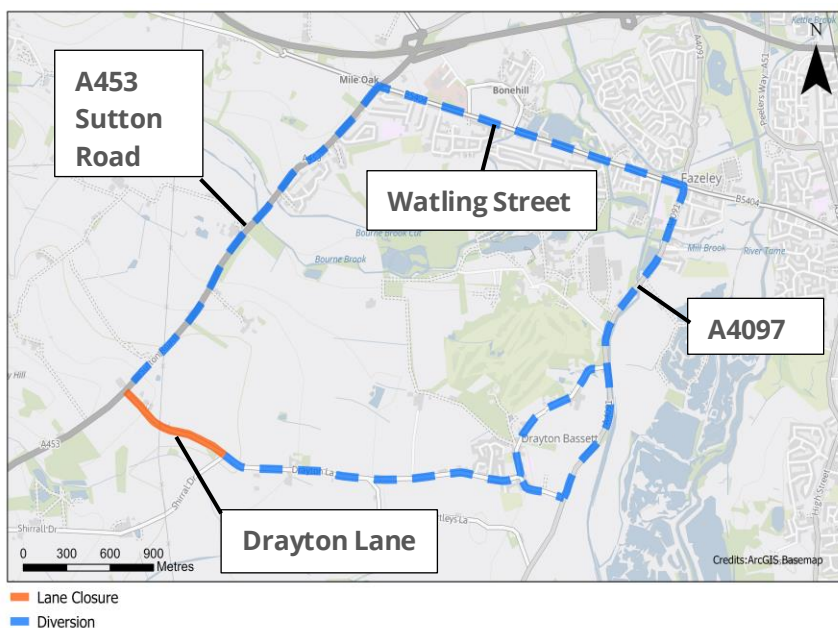
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

We will be undertaking emergency works to remove a tree that has been made unsafe due to recent weather conditions on Drayton Lane. To complete these works safely we must establish a safe working area which will require the temporary closure of Drayton Lane.

When the work will take place

These works will be completed on 5 February. The full closure of Drayton Lane will be in place for up to two hours and will start at 10am
