



Notice of temporary lane closures on Faraday Avenue and the A446

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

We will be undertaking works to construct the temporary diversion of Faraday Avenue which will enable the construction of Faraday Avenue Underbridge.

These works will require us to close one lane at a time whilst we complete surfacing works and hardening the central reservation before moving traffic onto the new temporary diversion.

When the work will take place

To complete these works safely we will install single temporary lane closures on Faraday Avenue and the A446 southbound as follows:

- **12 February to 15 March 2024** between 9.30am to 3.30pm and 8.00pm to 3.00am.
- **8 April to 22 May 2024** between 9.30am to 3.30pm and 8.00pm to 3.00am.

Whilst it is not possible at this stage to define the specific lane closures for each day these will be limited to A446 Southbound and Faraday Avenue.

Please note we have planned the required temporary single lane closures to avoid peak traffic flow periods.

Access will be maintained for pedestrians.

Temporary traffic management from 12 February until 15 March. Then from 8 April until 22 May 2024.

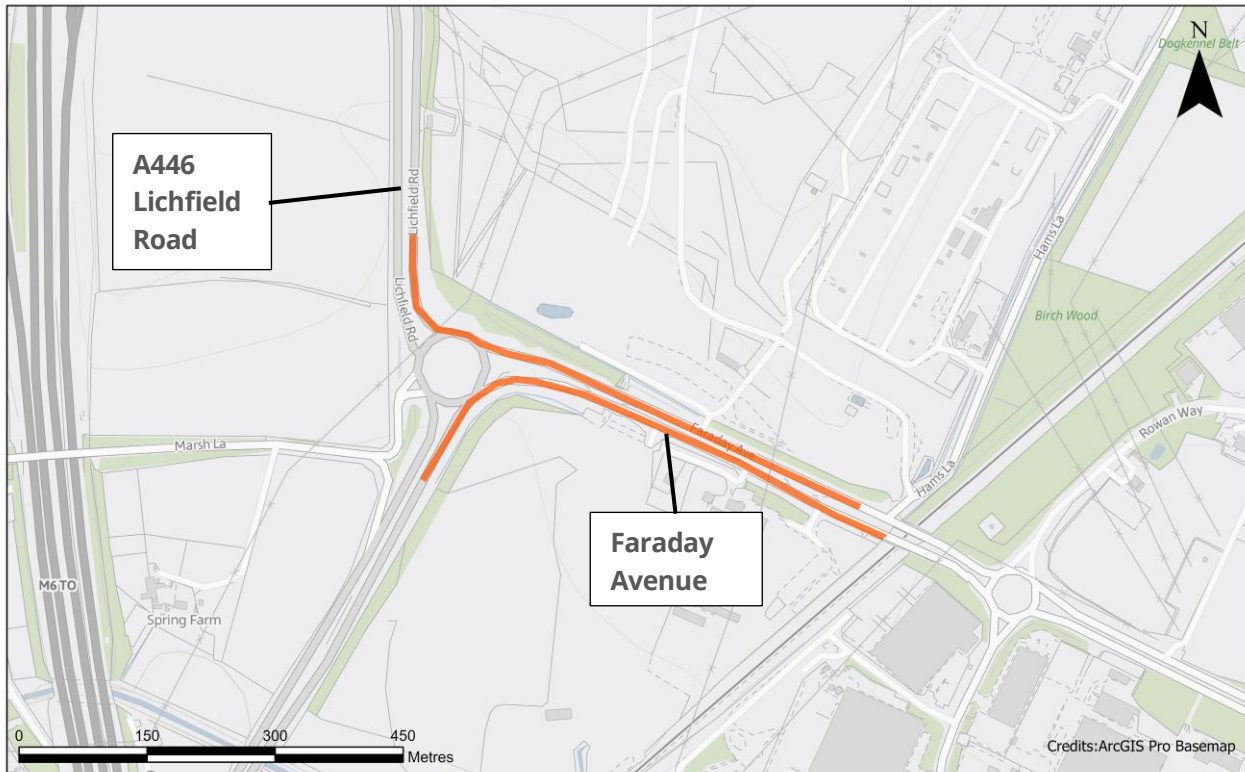
