What are we doing?

At the end of January 2024, we will be carrying out some works on the temporary gas main diversion on Gawcott Road by completing some gas trial holes. These works are planned to be completed under 2-way lights.

To carry out these works safely and effectively, a section of Gawcott Road/Perry Hill will require traffic management.

These works are an important step towards the re-alignment of Gawcott Road/Perry Hill over the new bridge, currently under construction.

When will these works take place?

A section of Gawcott Road/Perry Hill will be under traffic management from Monday 22 January until Sunday 4 February 2024, near to the entrance of the EKFB compound.

These dates may be subject to change due to circumstances outside of our control, such as weather.

Respond promptly to any complaints and take appropriate action.


