High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

In order to prepare for our continued construction in the area, BBV will be undertaking vegetation clearance from the footpath and creating a trench road crossing, to relocate a section of power cables.

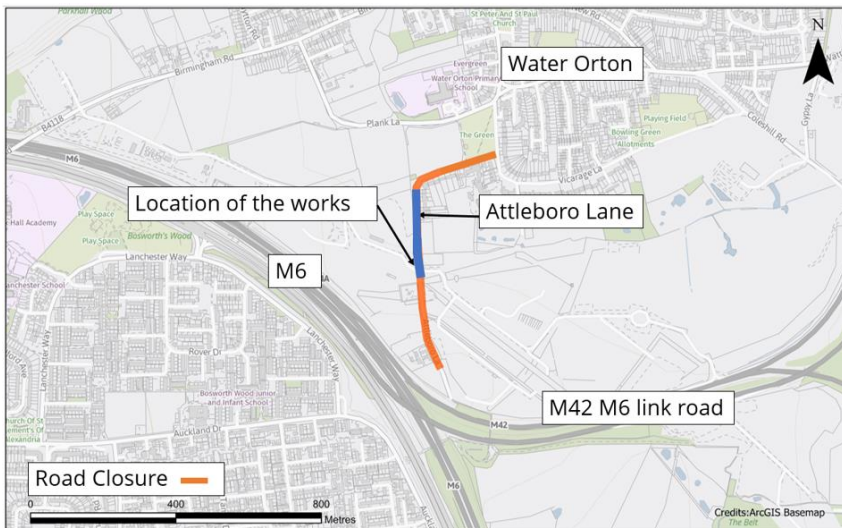
When the work will take place

To complete the works safely, we will install traffic management from Monday 22 January to Friday 23 February. The traffic management will be in place during our working hours which will be from 8am to 6pm each day.

Access to properties will be maintained throughout the works.
