High Speed Two (HS2) is the new high speed railway for Britain. This is a notification to inform you of temporary traffic lights on the A413, London Road, Buckinghamshire.

### What are we doing?

We need to make some emergency repairs to the pedestrian crossing area and to do this safely, we require traffic management.

# How will this affect you?

There will be a single lane closure and two-way traffic lights will be in place on London Road, near the junction with Kings Road:

- Thursday 18 January 2024
- From 9.30am to 3.30pm

Residents access will be unaffected.
