UPDATED: Notice of traffic management on Attleboro Lane, **Water Orton**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

In order to prepare for our continued construction in the area, BBV will be undertaking vegetation clearance from the footpath and creating a trench road crossing, to relocate a section of power cables.


When the work will take place

UPDATED: Due to unforcean circumstances, these works have been delayed one week. The traffic management will now commence on Monday 29 January to Friday 1 March. The traffic management will be in place during our working hours which will be from 8am to 6pm each day.

Access to properties will be maintained throughout the works.
