High Speed Two (HS2) is the new high speed railway for Britain.

Large load deliveries and collections

On Tuesday 30 January 2024, we shall be receiving large load deliveries to our worksite via Adelaide Road, NW3 3QA.

For safety reasons, these loads need to be moved at night or early in the morning outside peak traffic hours.

Due to the size and weight of these loads there may be occasions where our approved lorry routes are not suitable, and the haulier may need to use alternative roads. There may also be occasions when these movements will occur at short notice due to resources.

Our traffic management team will be present to assist the haulier to safely navigate the route and ensure that any disruption is kept to a minimum.
