# **Update: Notice of out of hours deliveries**

High Speed Two (HS2) is the new high speed railway for Britain.

### Out of hour deliveries to Victoria Road Crossover Box

We recently wrote to you about out of hours deliveries that were scheduled to be completed on 8 February 2024. These works will now be completed on **11 February 2024 between 8pm and 12am.** 

We are expecting two large deliveries of an overhead crane to the Victoria Road Crossover Box site.

The equipment being moved are wide loads which must be delivered during non-peak times, to reduce the impact on the road network.

# What to expect

You may hear reversing signals and engine noise during deliveries. We will be monitoring the noise levels throughout these works to ensure minimal disruption to residents.

Due to the size of the cranes being delivered there will be a short pause in traffic on Wales Farm Road and Victoria Road, whilst the deliveries are manoeuvred to site. This will take no longer than 10 minutes.
