# Notice of utilities work to the West of Euston Station

High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

# **Watermain commissioning Works**

As part of our essential programme of utilities works, we will complete and commission the new 1000mm water main with works taking place over three months in **Cumberland Market and Robert Street**.

These works will commence on **Monday 26 February 2024** until late May 2024. Working hours will be 8am – 6pm Monday to Friday, with occasional night time working when required.

We will ensure every effort is made to keep unnecessary noise to a minimum. Please note there will be no disruptions to local services.

Traffic Management will be in place for these works as detailed below, with pedestrian access being maintained at all times.




Image showing worksite; blue line is the existing main and the green line is the new main.

### **Duration of works**

- 26 February until late May 2024
- 8am and 6pm
- Night works on 2<sup>nd</sup> and 11<sup>th</sup> April between 10pm and 5am (subject to changes)
- Start-up and closedown activities up to one hour before and up to one hour after working hours above

### What to expect

- Temporary worksites where work is taking place
- Traffic management in place
- Pedestrian access will be maintained
- Partial closure of Robert Street
- Periodic noise from work site

### What we will do

- Aim to reduce noise and vibration as reasonably practicable
- Keep all sites safe and secure

### What to expect

We recognise that construction work can be disruptive to those living or working nearby. The nature of our work often means some disturbance is unavoidable, but every effort is made to minimise any unnecessary noise and the time we need to spend at this location. Please note that changes to the programme may occur and we will continue communicate changes.

### Works will include:


- Breaking out road surface
- Use of hand tools, compressor, generator and dumper
- Traffic management will be in place
- We expect our works to be noisy at times however we will work to minimise disruption with the use of acoustic barriers
- Alterations to public walkways;

### **Working hours**

- 8am to 6pm weekdays (excluding bank holidays)
- Night-time work (10pm to 5am) will be required for activities that can only be carried at night
- We will start-up and close-down activities up to one hour before and up to one hour after normal working hours above; and
- Intermittent delivery of materials to site may be required before 7am and after 7pm for materials not permitted on London roads during the day.

# **Hampstead Road Hoarding Change**


In the upcoming weeks we will be carrying out a change of our hoardings along Hampstead Road. During these works the southbound cycle lane will be suspended to facilitate a small pedestrian diversion into the carriageway.
